Philosophy

Massage, Reiki, and Acupressure are three of many holistic techniques designed to bring about relaxation, reduced muscle tension, stress reduction, and general well being. My approach is one of treating the whole person – body, mind, and spirit.

Your rights as a Consumer of alternative health care services:

- * You have the right to reasonable notice of changes in service or charges
- * You have a right to complete and current information concerning the massage therapist's assessment and recommended service that is to be provided, including the expected duration of the service to be provided.
- * You, the client, may expect courteous treatment and to be free from verbal, physical, or sexual abuse by the massage therapist.
- * Your client records and transactions with the massage therapist are confidential, unless release of these records is authorized in writing by you (the client), legal guardian, or otherwise provided by law.
- * You have the right to have access to your personal records
- * You have the right to choose any holistic practitioner freely, and to change practitioners at any time.
- * You have the right to coordinate transfer of your records when there will be a change in the provider of services
- * You have the right to refuse services or treatment, unless otherwise provided by law.
- * You have the right to assert your client rights without fear of retaliation.
- * You have the right to receive treatment and services from other practitioners along with, or instead of treatment and services provided by Scott Schumacher. *You may find a list of other providers and Practitioners in the phone book or other internet resources.*
